CLÁUSULA PRIMEIRA: Fica convencionada entre as partes a prorrogação de prazo do Contrato de licença de uso de software que integra o Processo Administrativo nº 133/2024, por mais 12 (doze) meses, contados a partir de 16 de abril de 2024.

CLÁUSULA SEGUNDA: O valor global do contrato é de R\$ 9.109,80 (nove mil, cento e nove reais e oitenta centavos), que serão adimplidos em 12 (doze) parcelas mensais de R\$ 759,15 (setecentos e cinquenta e nove reais e quinze centavos).
